### Scope of Research

#### **SFP Pages 13-15**

The first part of the regional plan presents a baseline of the region. It considers the region's stakeholders, assesses the factors affecting the region's economic, environmental, and health conditions, and conducts detailed economic and workforce analyses. ### General Notes

This committee will focus on how the H RTP analyzes, translates, and leverages data to drive opportunities to disinvested communities.

Is there a way that we can collect and utilize reports and data that already exists and that this group can draw from (LA County Public Health Study, Climate Risk Study)?

Other considerations to inform the rest of the work include:

- types of studies that will be required
- how will this group go about conducting these studies?
- to what level of detail (subregion, zip code, census tracts, etc.)
- what is the realistic price point/budget to help collect substantive data
- Types of analysis and data survey: deeper dives, greater aggregation
- How is the data going to be disaggregated?

The challenge is that LA County is a gigantic region with extremely diverse issues → The group needs to decide how to narrow it down so that we can start collecting data.

It would also be valuable to identify barriers and issues directly correlated with quality-of-life opportunities:

- broadband technology access (digital divide)

- childcare access
- Generational barriers (language)
- understand the skill set of communities (education, current employment, etc.)
- Physical location/access to quality jobs (transportation access, cost, and avenues)
- Small Business needs (available capital, mentorship, training, peer networking, etc.)

This committee should look to serve as a clearinghouse of relevant data and information → **Action Item:**  
Submit relevant data reports

How do we also ensure that the data that we create is also digestible for our communities and can be used to inform multiple stakeholder groups.

#### Facilitator Selection

Would be strategic to pair a subject matter expert with a community partner to develop a data-driven AND data-informed approach for this group.
